



## 2019 Technology Awareness Day Mobile App Design Contest Official Rules

### SPONSOR

Sponsor is BNSF Railway ("Sponsor" or "BNSF").

### TERM

The 2019 BNSF Railway's Technology Awareness Day Mobile App Design Contest ("Contest") begins November 12<sup>th</sup>, 2018 and ends January 29<sup>th</sup>, 2019.

Mobile App Design contest registration should be completed at the time registration for the event is submitted by the designated Career and Technology Education (CATE) coordinator or Upward Bound coordinator at your school. **Note: You must check the box for the contest(s) you want to enter.**

Completed Mobile App Design entries must be received by BNSF TAD Contest Committee no later than **January 29<sup>th</sup>, 2019. Entries received after this date will not be considered.**

Information on how to enter and prizes form part of these official rules ("Official Rules"). By submitting an entry, each entrant agrees to the Official Rules and warrants that his or her entry complies with all requirements set out in the Official Rules. This is a skill-based contest and chance plays no part in the determination of winners.

### WHO MAY ENTER

Eligibility:

The contest is open only to students of participating schools or programs who are in 9<sup>th</sup> through 12<sup>th</sup> grades at the time of entry.

One contest entry, per category submission, per student. There is no cost to enter the contest.

Past Grand Prize Winners are not eligible to participate in the category they won.

### HOW TO ENTER

Each Entry consists of

- A cover sheet with the Contest Title, Student's Name, School, and Grade
- An electronic copy of the Essay
- An electronic copy of a PowerPoint presentation illustrating the Mobile App Design and process flow with the Student's Name, School and Grade as the Title
- A Bibliography page with at least 2 references



- **Design a mobile app that solves a real-world problem and illustrate the solution in a PowerPoint presentation. Show how your mobile app might look and how a user would navigate through the app using a process flow.**

The contestant must explain the real-world problem and the solution they have presented.

**Incomplete entries will not be considered.**

Your entry must comply with the following requirements (the "Entry Requirements"):

All Mobile App Design submissions must be in **PowerPoint** format.

Contestants can use any applicable design software; the entry must be submitted in **PowerPoint** format.

Inappropriate use of language and/or images will automatically disqualify an entry.

The essay must adhere to the following guidelines:

- An original, unpublished work
- One page in length. Maximum two pages.
- Double-spaced, Times New Roman, 12-point font
- Contestants should proofread entries for spelling and grammar.

Each Entry must be developed with limited guidance from others.

Each Entry must be a single work of original material taken by the contest entrant.

By entering the Contest, entrant represents, acknowledges and warrants that the submitted Mobile App Design Presentation and Essay are original works created solely by the entrant and that no other party has any right, title, claim or interest in the Mobile App Design Presentation or the Essay.

Though you retain copyright in each Mobile App Design submitted, the Mobile App Design(s) submitted will not be returned or acknowledged.

Obscene, provocative, inappropriate use of language or otherwise objectionable content will not be considered, and such determination is solely at the discretion of Sponsor.

The entries will be judged in accordance with the Judging Criteria, as defined below.

All entries must be submitted and received by January 29<sup>th</sup>, 2019. Proof of submission is not proof of receipt.



## LICENSE

Each entrant retains the copyright to his/her Mobile App Design(s) and Essay(s), but explicitly grants Sponsor, its licensees, affiliates and their designees (collectively, the “Authorized Parties”) an irrevocable, non-exclusive license for the duration of copyright to use each Mobile App Design and Essay for advertising, marketing, and promotional purposes, in any and all media now known or hereafter created, including but not limited to publication in catalogs, brochures, blogs, and websites, at Authorized Parties’ discretion, without additional consideration, notification, permission to entrant or any third party.

## CONTEST PRIZE

- One (1) Grand Prize Winner, one (1) Second Place Winner, and one (1) Third Place Winner will be selected.
- The top three finalists of each category will be recognized at Technology Awareness Day on **February 16, 2019. Winners must be present to receive their prize. If they are not available, the prizes will be awarded to the next highest qualifier present.**
- No prize transfer or assignment by winner permitted. No cash equivalent will be provided. Sponsor reserves the right to substitute prize in the event of unavailability.
- Odds of winning depend on the number of eligible entries received and the skill of the entrant.

## JUDGING CRITERIA AND CONDITIONS

Judges will select the top entries by applying the following criteria (“Judging Criteria”):

- 1) Mobile App Design Quality (75%)
  - a) Clarity of Presentation, Content and Visual Appearance (25%)
  - b) Recognizing and solving a real-world problem (20%)
  - c) Ease of navigation through the mobile app as illustrated in the design presentation (15%)
  - d) Creativity and Originality (15%)
- 2) The quality of the Essay (25%)
  - a) Style and Mechanics (grammar, sentence structure, etc.) (10%)
  - b) Quality of work (15%)

Decisions of the Judges are final.

## LIMITATION OF LIABILITY

Regulations and conditions may apply.

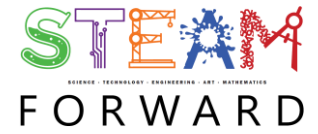
## **RIGHT TO CANCEL OR SUSPEND CONTEST**
