On April 25, 2002, the Reporting Person voluntarily reported receipt of a grant of 3,100 shares of restricted stock pursuant to the Burlington Northern Santa Fe 1999 Stock Incentive Plan, with vesting contingent upon performance-based measures. Because the Reporting Person had made an election prior to the grant to defer the award into the Senior Management Stock Deferral Plan, he was awarded (1) securities that did not accrue to his benefit until performance criteria had been met, and therefore should not have been reported upon issuance. This filing is being made to remove the line item reporting these shares in the original filing.
