GENERAL RULES

- Freight charges must be prepaid.
- Price applies in U.S. Funds.
- Price is not subject to a Fuel Surcharge.
- Transportation under this agreement is subject to BNSF Rules Book 6100-Series in effect as of the date of shipment. A copy of this Rules Book may be obtained via the internet at: www.BNSF.com.
- Prices in this Rate Item Price List do not alternate with other Rate Item Price Lists.
- DET RULES: Rates in Column 1 & 2 apply when shipment is part of a 110-120 car DET unit: DET's must:
- 1. Be designated as DET freight via the COT's Desk. All terms in Item 13504 apply and must be met to qualify to get the DET rate;
- 2. Load by one consignor at one origin elevator capable of loading all cars on a single switch;
- 3. All cars within a DET must be pre-blocked by consignor at origin by destination, and destination carrier;
- 4. Bill on multiple bills of lading, cross referenced to one another, noting they are part of a 110 car or more unit train, with a minimum of 24 cars per block specifying consignee, final destination and complete routing instructions and provide a single freight payer;
- 5. All cars within a DET must be billed to the destinations in a single group, and no DET train may be billed to more than one of the export elevators which are limited to only 55 cars below;
- 6. Cars billed to the same destination need to be loaded in consecutive cars;
- 7. Failure to properly pre-block at origin will result in assessment of single car rates for the entire 110 cars;
- 8. Column 1 & 2 DET rates require cars to be blocked by destination group. Destination groups are defined as follows:
- MSP GROUP: Fridley, MN, Minneapolis, MN, Cochrane, WI, Duluth, MN; Superior, WI.
- 9. Destination groups can only be blocked with the following destination group combinations. Order of the destination group blocks is at the discretion of the shipper, however, similar destination blocks must be next to each other in order:
- MSP MSP MSP MSP
- MSP MSP MSP KCK
- MSP MSP CHI CHI
- MSP MSP CHI KCK
- MSP MSP KCK KCK
- CHI CHI KCK MSP
- MSP MSP MSP CHI
