



## 2025 Technology Awareness Day Video Contest Official Rules

### SPONSOR

Sponsor is BNSF Railway ("Sponsor" or "BNSF").

### TERM

The 2025 BNSF Railway's Technology Awareness Day Video Contest ("Contest") ends on January 31, 2025.

Video contest registration should be completed at the time registration for the event is submitted by the student participant but is not required to participate.

Completed Video entries must be received by BNSF TAD Contest Committee no later than **January 31, 2025. Entries received after this date will not be considered.**

Information on how to enter and prizes form part of these official rules ("Official Rules"). By submitting an entry, each entrant agrees to the Official Rules and warrants that his or her entry complies with all requirements set out in the Official Rules. This is a skill-based contest and chance plays no part in the determination of winners.

### WHO MAY ENTER

Eligibility:

The contest is open only to students at participating schools or programs who are in 9th through 12th grades at the time of entry.

One contest entry, per category submission, per student. There is no cost to enter the contest.

As of 2024, Past Grand Prize Winners are now eligible to participate in the category they won.

### HOW TO ENTER

Each Entry consists of

- Cover sheet including the Contest Title, Student's Name, School, and Grade
- Word document explaining the video
- A video file of between one and three minutes in length
- A video file in MP4, MOV, or MPG format
- A Bibliography page as needed

The theme for the video and essay is **"Authenticity in AI" Please demonstrate what that means to you.**



The contestant must explain how they would interpret the theme.

**Incomplete entries will not be considered.**

The student participant must submit contest entries directly to [TAD@bnsf.com](mailto:TAD@bnsf.com) by email. You may contact the TAD Committee by email regarding any questions.

Your entry must comply with the following requirements (the "Entry Requirements"):

Contestants can use any applicable video recording/editing applications including social media platforms, as long as the video file is shared as a public link or an MP4, MOV, or MPG file. As of 2023, there is no minimum length. The video should be no longer than 3 minutes. The length of video will not directly impact the judge's score.

Inappropriate use of language and/or images will automatically disqualify an entry.

Each Entry must be developed with limited guidance from others.

Each Entry must be a single work of original material taken by the Contest entrant.

By entering the Contest, the entrant represents, acknowledges and warrants that the submitted Video and Essay are original works created solely by the entrant and that no other party has any right, title, claim or interest in the Video.

Though you retain copyright on each video submitted, the video(s) submitted will not be returned or acknowledged.

Obscene, provocative, inappropriate use of language, or otherwise objectionable content will not be considered, and such determination is solely at the discretion of Sponsor.

The entries will be judged in accordance with the Judging Criteria, as defined below.

All entries must be submitted and received by January 31, 2025. Proof of submission is not proof of receipt.

## **LICENSE**

Each entrant retains the copyright to his/her Video(s) and Essay(s), but explicitly grants Sponsor, its licensees, affiliates and their designees (collectively, the "Authorized Parties") an irrevocable, non-exclusive license for the duration of copyright to use each Video and Essay for advertising, marketing, and promotional purposes, in any and all media now known or hereafter created, including but not limited to publication in catalogs, brochures, blogs, and websites, at Authorized Parties' discretion, without additional consideration, notification, permission to entrant or any third party.

## **CONTEST PRIZE**

- One (1) Grand Prize Winner, one (1) Second Place Winner, and one (1) Third Place Winner will be selected.




- The top three finalists of each category will be recognized at Technology Awareness Day on **February 8, 2025. Contestants must attend the Awards Ceremony to be able to receive their prize. If a contestant is not able to attend, they must notify us by January 31, 2025**
- No prize transfer or assignment by winner permitted. No cash equivalent will be provided. The sponsor reserves the right to substitute the prize in the event of unavailability.
- Odds of winning depend on the number of eligible entries received and the skill of the entrant.

### **JUDGING CRITERIA AND CONDITIONS**

Judges will select the top entries by applying the following criteria ("Judging Criteria"):

- a) Presentation and Visual Appearance (25%)
- b) Adherence to Theme (25%)
- c) Originality (25%)
- d) Creative Expression (25%)

Decisions of the Judges are final. 

### **LIMITATION OF LIABILITY**

By participating, participants agree to release, discharge and hold harmless BNSF Railway and its partners, affiliates, subsidiaries, tour operators, agents and their employees, officers, directors, and representatives from any claims, losses, and damages arising out of their participation in this Contest or any Contest-related activities and the acceptance and use, misuse, or possession of any prize awarded hereunder.

BNSF Railway assumes no responsibility for any error, omission, interruption, deletion, defect, or delay in operation or transmission; communications line failure; theft or destruction of or unauthorized access to Contest entries or entry forms; or alteration of entries or entry forms. ineligible or refuses the prize, the prize will be forfeited and Sponsor, in its sole discretion, may choose whether to award the prize to the next highest qualifier present.

Regulations and conditions may apply.

#### **RIGHT TO CANCEL OR SUSPEND CONTEST**

If for any reason the Contest is not capable of running as planned, due to infection by computer virus, bugs, worms, Trojan horses, denial of service attacks, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of BNSF that corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Contest, BNSF reserves the right, at its sole discretion, to disqualify any individual(s) who tamper with the entry process, and/or to cancel, terminate, modify, or suspend the Contest. If Sponsor elects to cancel or terminate the Contest, Sponsor will not retain any rights to the submitted photographs.

#### **DATA PRIVACY**

Entrants agree that personal data, especially name and address, may be processed, shared, and otherwise used for the purposes and within the context of the Contest and any other purposes outlined in these Official Rules. Personal data will be used by Sponsor and its affiliates exclusively for the purposes stated herein.
