- Switching charges at Origin and Destination will be absorbed up to \$160.00. No more than \$160.00 per car will be absorbed. Any additional amount will be assessed. For SDIY No switching will be absorbed.
- Prices in this Rate Item Price List do not alternate with other Rate Item Price Lists.
