Payments of freight charges on interline through rates within this price authority are as follows: Freight charges must be prepaid when BNSF is the originating carrier. Freight charges must be collect when BNSF is the terminating carrier.
- Price authority is subject to change without notice.
- The Transportation Contract number, correct address and patron code must be shown on the bill of lading to ensure accurate billing.
- Freight charges must be collect.
- Switching charges at Origin and Destination will be absorbed up to \$295.00. No more than \$295.00 per car will be absorbed.
