BNSF 90022 ITEM 2001

1 TEXT	Rates will apply from origins and destinatons served by the BNSF via BNSF direct, when origin or destination is Glendale, AZ; McPherson, KS; Brainerd, Cloquet and Grand Rapids, MN and Clearfield, UT. These rates may be used when constructing combination rates for movements originating or terminating on other carriers. However, interline forwarded traffic must be routed to the furtherest BNSF junction point. Conversely, interline received traffic must be routed to nearest BNSF junction point to maximize BNSF's long-haul movement. When BNSF serves both origin and destination, traffic must be routed BNSF. An Additional charge of \$600 per car will be assessed when shipments do not comply with above BNSF maximum haul requirements.
